QUESTION 1

- (a) "Parliamentary legislation is a better source of the Kenya law than subsidiary legislation." Discuss this statement with a view to highlighting only the positive aspects of it. [4 marks]
- (b) A proposes to have an insurance policy; B issues one to A subject to payment of premium. A does not pay premium. B files a suit to recover the premium. Will B succeed? [4 marks]
- (c) Aoffers by fax to purchase certain shares of B, in circumstances indicating that acceptance was to be by telegram. B faxes a letter of acceptance, which was lost. Is there a contract? [4 marks]
- (d) A horse was sent by railway from Nairobi to Kisumu. However, the owner was not present to collect it on time. The station master at Kisumu arranged for its feeding and stabling incurring an expense of Ksh.10,000/=. The station master filed a suit to recover the money and the owner of the horse refused to pay, decide. [4 marks]

- (e) Chuka University College commended a periodical publication called "Varsity Post" and engaged B to write a volume on sports activities in the college. For this purpose B was to receive the sum of Ksh.100,000 on completion of the work. When he had completed a part, but not the whole of his volume, Chuka University College abandoned the publication. B sued the college for recovery of the amount of the contract. Does the college have a defence against B's claim? Give reasons for your answer. [4 marks]
- (f) Three weeks ago the High Court delivered a judgment in a case in which Peter was accused of mutiny in the Kenya Armed Forces. Having been convicted of the offence, he thinks the judgment was very unfair. He has come to you to advise him, do so, by stating with explainary the nature of the court which found him guilty before the High court also did. [4 marks]
