Opiyo: Having worked as a Head Waiter at Kisumu Sunset Hotel for five years, I decided that I wanted to have a business of my own. I knew I could succeed in a restaurant business because I had served many customers and was now aware of their needs and expectations. I visited many restaurants and hotels within town and noticed that they were always crowded during lunch and dinner time. I used to pass near Kisumu bus terminus and I was always amazed at the large crowd of people around this place. I resigned from my job, rented this place and started "Wananchi Restaurant"

<u>Kevo</u>: I am a welder by profession and did my training at Kisumu polytechnic. I started by working for my uncle who had three welding machines. He had many customers ordering steel window frames, beds, gates and containers. After three years, I bought my own welding machine and started my own business. The market was there and one could see the town expanding rapidly in terms of infrastructure, buildings and industries. After

five years, I had six welding machines and ten employees. I was getting large orders from building contractors and hardware stores. It was then that I decided to open a hardware store so that I could cater for more customers.
