Law refers to a set of rules or principles that govern the conduct of affairs in a given community at a given time, whereby machinery is provided for aggrieved party to enforce his rights in case any of these rules or principles is broken. These laws are the totality of rules which are enforced by the courts in the course of their daily work in dispensing justice. The sources of these laws is provided in Section 3 of the Judicature Act (Cap 8) of the laws of Kenya.
