- (d) What guidelines would you base on as a teacher while writing instructional objectives for your lesson? (5marks)
- (e) State three reasons why psychology of learning is an important screen for sieving information used in curriculum decision making. (3 marks)
- (f) The current Early Childhood Development and Education (ECDE) curriculum for children between 3-6 years in Kenya has been developed with regard to the children's developmental stages.
(i) State four goals of ECDE in Kenya (4 marks)
(ii) Explain three challenges that the ECDE programme faces. (3 marks)
- (g) Briefly explain any five current issues in teacher education in Kenya. (5 marks)

- (a) Explain five conditions that justify teaching as a professional human activity. (5 marks)
- (b) Discuss any five factors in society which influence the shape of the school curriculum. (15 marks)

Question Three

- (a) Curriculum implementation is the sole legitimate task of the teacher. Discuss. (10 marks)
- (b) Discuss the barriers to curriculum innovation. (10 marks)

Explain the functions of each of the following institutions in the curriculum development process:

- (a) Kenya, Institute of Curriculum Development (12 marks)
- (b) The Directorate of Quality Assurance and Standards (4 marks)
- (c) The Kenya National Examinations Council (4 marks)

Question Five
