## **Question One**

- a) Citing examples from the four broad areas of preferred learning styles, explain why a teacher in Early Childhood Education needs to use a wide variety of teaching/learning materials during instruction. (6marks)

- c) Citing examples to support your answer, describe two approaches that you might use to organize and store teaching and learning materials for use in an early childhood class. (4marks)
- d) Different methods could be used to display learning materials in Early Childhood Education. Describe three methods that you will use to display the learning materials. (3marks)
- e) One way of acquiring instructional materials for use in Early Childhood Education is by collecting them from the community. Describe three steps that you will take to prepare the collected materials for use by the young children. (3marks)

f) Elucidate three steps that you will follow in an attempt to mobilize the community for materials collection and development. (3marks)

## **Question Two**

- a.) Using examples to support your answer, enumerate three categories of instructional materials that you could use for teaching and learning in Early Childhood classes.

- b.) One type of instructional materials that is commonly use when teaching young children are flash cards. Using examples drawn from the language activity area, describe three ways in which you will use flash cards when teaching young children.

- c.) Real objects are another type of instructional materials that a teacher should use to teach young children. Explain the benefits of using real objects when teaching young children. (6marks)
